Assistant Superintendent of Police (ASP) Under Training, Jehlum (02-06-1997 to 13-02-1998), I received practical on job training in the field, worked as Assistant

Superintendent of Police, Headquarters and Assistant Superintendent of Police Traffic and also carried out investigation and performed various duties.

ASP Headquarters & Sub-Divisional Police Officer SDPO, Saddar Beruni, Rawalpindi (14-02-1998 to 02-10-1998), I looked after the police lines, personnel and administration. As SDPO Saddar Beruni & Women Police Station dealt with urban and rural crime cases and supervised the external security arrangements of Central Jail (Adiala).

ASP Security (03-10-1998 to 28-01-2000), I dealt with security of VVIPs police Verification & Character Certificates, Office correspondence relating to the Senior Superintendent of Police, Islamabad Office.

These women and children were frequently brought to the Women Police Station in Islamabad, and their problems were solved with the collaboration of different NGO's.

Superintendent of Police (SP), Supreme Court & Investigation (2002), my job was to maintain the security of the Supreme Court of Pakistan and the Judges of the Supreme Court, supervision of all cases relating to property and persons of the districts. Overall, in charge of Forensic Lab, Criminal Record Office and Evidence Recovery Team.

<u>Deputy Director National Police Bureau (Feb-2003 to Nov-2005)</u>, I was entrusted the task to lay the ground work for the establishment of the National Public Safety Commission, supervision of the progress of District Public Safety Commissions throughout the country. Handling capacity buildings projects and training of police officers.

Superintendent of Police, Traffic (10-4-02 to 14-02-03) & (16-11-05 to 13-6-07), I had the responsibility of supervising the Islamabad Traffic Police, which included overall management of the traffic, training of newly recruited police force and introduction of Motorway Police model for effective management.
